The Budget Hearing of the Cuba Lake District Board of

Commissioners was held on Thursday, August 11, 2005,

At the Cuba Lake District Office, 15 E. Main Street, Cuba, New York

Co-Chairperson Erick Laine called the Budget Hearing to order at 6:59 p.m. and asked the Secretary to call the roll. Commissioners Collins, Shemeld, Bradley and Laine were present; also in attendance were the Lake Manager Dave Bosworth, Secretary Pam Konieczka, Attorney John M. Hart, Jr., Treasurer Andrew Lindquist, and guest, Jim Mostacato.

Commissioner Shemeld submitted the Budget for 2006. The action on the Budget will take place in the regular meeting.

It was stated during the Budget Hearing that the Seneca Nation of Indians were notified of the Budget Hearing meeting and were copied on the Budget, but chose not to comment at the Public Hearing.

It was also stated that there is a cash reserve of \$24,000.00 in the budget, therefore there would be no need for any tax increase even considering the loss of tax revenue due to the return of the land to the Seneca Nation of Indian.

Commissioner Jeff Bradley adjourned the Budget Hearing at 7:12 p.m.

TREASURER'S REPORT: Following review of reports of the District Budget circulated by the Treasurer, Commissioner Bradley moved to accept the Treasurer's reports for filing, seconded by Commissioner Collins. Following review of reports of the Management Budget circulated by the Lake Manager, Dave Bosworth, Commissioner Bradley moved to accept the Lake Manager's reports for filing seconded by Commissioner Collins. All in favor 4 yes, 0 no. MOTION CARRIED.

Following presentation of the List of Claims for the Management Account,

Commissioner Shemeld moved to pay the accounts as listed, seconded by Commissioner Collins. All in favor 4 yes, 0 no. MOTION CARRIED.

Dave Slotman, as requested by Lynn Sweet, provided documentation, through Dave Shemeld, showing exclusions to the general rule that the District consists of all areas of land from the centerline of the highway and earthen dam surrounding Cuba Lake inward. Document pages have no title but are identified as "S. 2933—B" and "A. 3618—B"; pages 3, 4 & 5. Also a section of a lot map extending from lot 313 through 333 was provided. Mr. Slotman also has other survey maps of the area that he briefly reviewed with Mr. Shemeld.

The documents will be reviewed in comparison to the legislation which established Cuba Lake District (Chapter 263 of the Laws of 1981).

## **ACTION LIST REVIEW:**

Commissioner Shemeld reviewed the Action List for the previous month.

### LAKE MANAGER'S REPORT:

Lake Manager Dave Bosworth reported the following items in addition to the action list:

It was decided that further investigation should be done including finalization of weed identification and establishment of a corrective action plan. Commissioner Shemeld agreed to look further into the situation with contacts through FOLA and/or Cornell U. or other resources.
